MISSION STATEMENT

To identify risks in medication use systems, recommend optimal system safeguards, and advocate for safe medication practices.

STRATEGIC STRATEGIC

ENABLE

- Expand national, provincial and local programs to support capability and capacity-building for effective incident analyses (using Concise, Comprehensive and Multi-incident methodologies), share learning, and implement quality improvement initiatives.
- Provide experts to complete or assist in local incident analyses, including a focus on supporting Long Term Care settings to identify and address key medication safety risks.
- Identify and address preventable adverse drug reactions with partners such as patients, families, professionals and Canada Vigilance, including supporting the implementation of Vanessa's Law.

EDUCATE

- Partner with patients, families, healthcare delivery, quality and safety organizations, educational institutions, and health professional regulators and associations to enhance online learning opportunities. This includes:
- Medication Safety Modules, with a focus on human factors and safety culture, for patients, families, nurses, pharmacists, physicians and others.
- Expand other areas of education programing and networking to better support those in roles with a focus on improving medication safety.

3 DELIVER

- Collaborate to increase the volume and quality of reports to the Canadian Medication Incident Reporting and Prevention System. This includes:
- Upgrade the Community Pharmacy Incident Reporting System (CPhIR);
- Increase awareness and use of Consumer reporting (SafeMedicationUse.ca); and,
- Increase awareness and use of the Individual Practitioner Reporting (IPR) system.
- Accept, analyze and forward to Health Canada reported adverse drug reactions/allergies/ side effects.
- Continue to provide expert analysis of submitted reports and deliver evidence-based recommendations for improving patient safety.
- Establish partnerships to develop and implement a national medication incident reporting and learning research strategy.

ENGAGE

- Expand our engagement with the public and stakeholders, and regularly share our activities and impacts. This includes:
- Update and refresh our website to be more user-friendly;
- Expand our reach through social platforms; and,
- Provide regular public updates through e.newsletters and publications.
- Collaborate to identify legislative, policy and regulatory gaps and advocate for options to advance medication safety through these mechanisms.
- Support the federal, provincial and territorial governments in the achievement of their medication safety goals.
- Enhance capability and capacity for program evaluation and continuous quality improvement.

4 INNOVATE

- Create, test and formalize leading-edge organizational practices to develop and retain a high calibre and high-performing ISMP Canada team.
- Develop new and innovative enhancements for information systems that also integrate industry leading practices.
- Invent new and innovative programming to improve medication safety and expand funding sources.
